

Privacy Policy

WebleaseUSA respects your privacy on the Internet. As part of our company operations, we gather certain types of information about our contacts, and we would like to explain the types of information we assemble, what we do with it and how to correct or change your information.

What Information is Collected about WebleaseUSA Contacts

As part of the process in downloading WebleaseUSA information and in enrolling in any WebleaseUSA giveaway, you will be asked to provide an e-mail address and other contact information, as appropriate. This information may or may not be necessary, depending upon the action being taken. In some instances WebleaseUSA may require an e-mail address for enrollment into a promotional agenda. In all other instances, an opt-out option will be offered.

Cookies

In addition to information provided by visitors to our web site, WebleaseUSA monitors incoming and outgoing web traffic data for diagnosis of server problems for web administration purposes and uses this data to collect general demographic information about all visitors to our site. This information allows us to ensure that we provide the most desired information to our visitors. As an important part of providing quality service, WebleaseUSA may use cookies to store and track information.

A cookie is a small amount of data that is sent to your browser from a Web server and stored on your computer's hard drive. By modifying your browser preferences, you have the choice to accept all cookies, or be notified when a cookie is set, or to reject all cookies. WebleaseUSA will access only those cookies that we have generated.

Online Privacy and Children

The privacy of children online is of the utmost importance to us. WebleaseUSAs' Web site is a general

audience site and is not directed to, or intended for, children under the age of 16. In the event that you suspect WebleaseUSA has any information about a visitor under the age of 16, please contact us immediately at privacy@webleaseusa.com. so all information can be deleted from our records.

Confidentiality

WebleaseUSA will not sell or release identifiable visitor information to any third party without your permission and will limit disclosure of information to the following, where we believe in good faith that it is required to do so in response to a Subpoena or other legal process; where reasonably required to do so in order to maintain, update or otherwise implement WebleaseUSA data security measures, equipment, technical operations, etc.; or where reasonably necessary to identify, contact or bring legal action against persons or entities to preserve and/or enforce WebleaseUSA's rights.

WebleaseUSA makes all efforts to protect the confidentiality of all visitors and will never knowingly allow access to this information by any third party. We have made a significant investment in our server, database, backup and firewall technologies to protect information assets. These technologies have been installed as part of a complex security architecture and protocol.

Information Uses

WebleaseUSA uses visitor information to deliver promotions and to monitor, analyze and report campaign results internally. This data is in a non-personally identifiable aggregate form designed to analyze general trends and usage patterns.

Opt-Out Provision

WebleaseUSA will offer an opt-out in all e-mail transmissions and will follow up with timely removal of requested information from our database. This information could include name, title, company, address, phone number, fax number, e-mail address or other information that has been offered.
